1. EXECUTIVE SUMMARY

ROYAL CAPITAL 369 (RC369)

Royal Capital 369 (RC369) is a community-based utility token designed to support a blockchain-powered reward and loyalty system connected to the distribution of physical consumer products within the Royal Capital ecosystem.

RC369 tokens are distributed free of charge to eligible participants as a form of digital loyalty reward, linked to verified product purchases and community participation. This system aims to enhance transparency, traceability of distribution, and community engagement through a decentralized approach.

RC369 does not represent ownership, profit rights, dividends, or revenue sharing, and does not provide any promise of value, price appreciation, or financial benefits of any kind arising from the holding or use of the token.

The primary function of RC369 is to serve as a utility and community reward token, supporting loyalty programs, community activities, and ecosystem features, while maintaining compliance with applicable regulations related to digital assets and consumer products.

2. BACKGROUND

Most consumer product loyalty programs remain centralized, lack transparency, and are difficult to independently verify. Blockchain technology enables reward systems that are more transparent, publicly auditable, and community-oriented.

Royal Capital 369 connects the purchase of physical consumer products (cigarettes) with digital community assets, creating added value for consumers without affecting the retail price of the products.

3. VISION AND MISSION

Vision

To build a transparent, sustainable, and community-oriented token ecosystem based on real-world consumption.

Mission

- To provide free token rewards linked to product purchases
- To enhance consumer loyalty through blockchain technology
- To encourage organic community growth
- To develop a regulatory-aligned utility token ecosystem

4. DEFINITION OF ROYAL CAPITAL 369 (RC369)

RC369 is a community-based utility token that:

- Is distributed as a bonus linked to verified cigarette product purchases
- Is used to support loyalty programs and community activities
- Is not marketed or designed to function as a financial instrument
- Does not grant ownership rights, dividends, or profit-sharing of any kind

RC369 serves as a bridge between offline activities (physical cigarette products) and a blockchain-based digital ecosystem, within a community and loyalty framework.

5. COMMUNITY TOKEN CONCEPT

RC369 is designed based on the following principles:

- Utility over speculation
- Real-world activity over financial promises
- Community value over centralization

Holders of RC369 are positioned as community participants rather than investors.

6. MULTILEVEL AIRDROP SYSTEM

6.1 Core Concept

The Multilevel Airdrop is a community-based token distribution system in which tokens are granted as a form of community loyalty appreciation. The distribution is not structured as a commission, financial incentive, or value-based reward scheme.

6.2 Distribution Mechanism

- Consumers purchase official cigarette products within the Royal Capital ecosystem
- Consumers submit token claims through the designated digital system
- RC369 tokens are transferred to the user's wallet
- Additional rewards may be obtained through community participation

All participation is voluntary and does not involve any financial obligation.

7. CIGARETTE PRODUCT INTEGRATION

Royal Capital 369:

- Does not sell cigarette products directly
- Does not influence or modify cigarette product pricing
- Distributes tokens solely as loyalty-based bonuses

RC369 tokens are not intended as tools to promote consumption, but as instruments to support community loyalty and engagement.

8. CIGARETTE PRODUCT REGULATORY COMPLIANCE

RC369 is developed in accordance with the following compliance principles:

- Product distribution adheres to applicable laws and regulations
- No targeting of minors
- No health-related claims are made
- Tokens are not used as price discounts or promotional reductions

9. DIGITAL ASSET REGULATORY COMPLIANCE

RC369 is designed as a utility- and community loyalty-based token with the following characteristics:

- It does not provide any promise, expectation, or projection of financial returns
- It does not grant rights to profit-sharing, revenue, or ownership
- It is not designed for fundraising purposes or activities intended to generate financial gain
- Tokens are obtained as part of community and loyalty programs, including free distribution

- Utility Token
- Loyalty Token
- Community Reward Token

10. TOKENOMICS

10.1 Total Supply

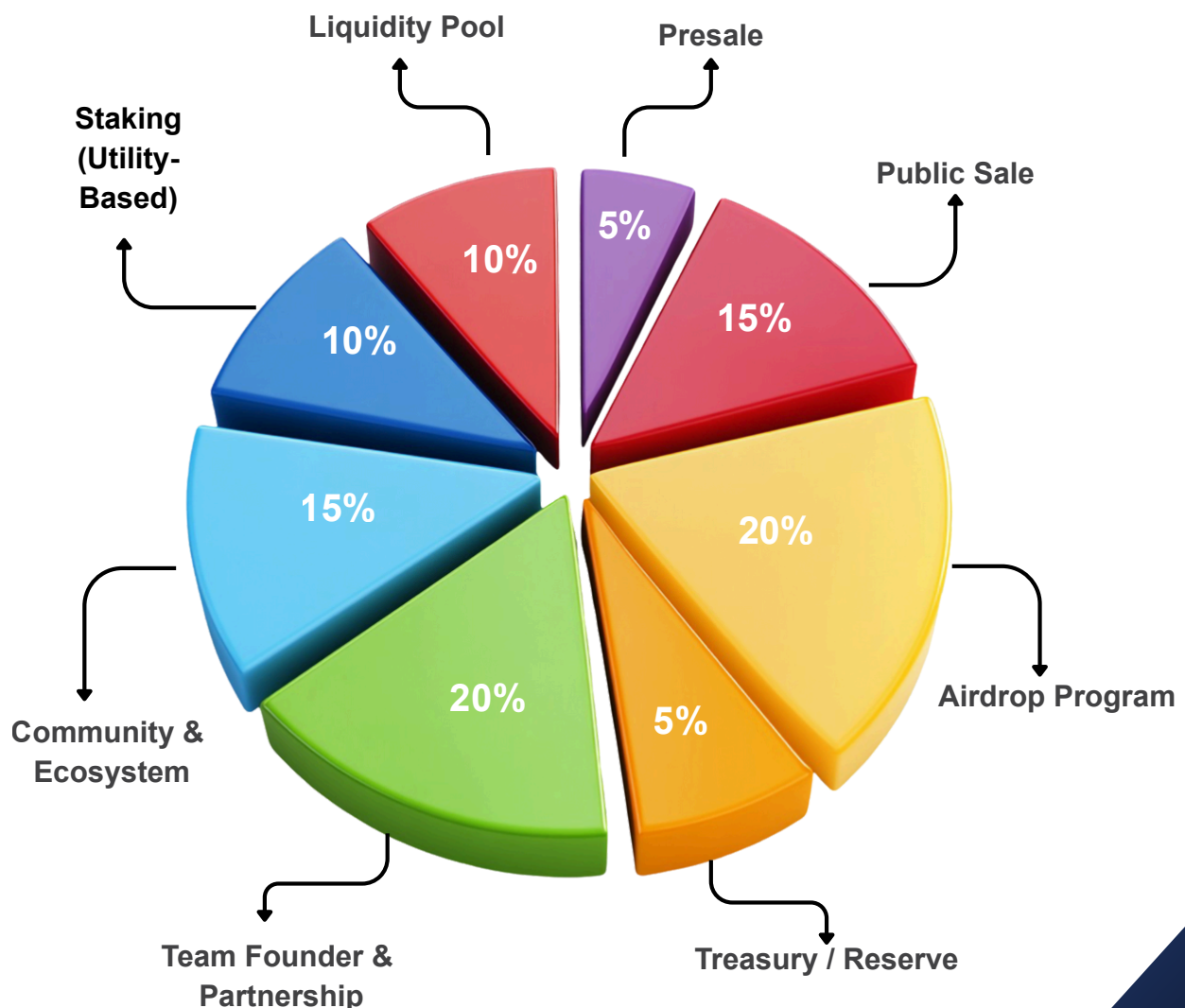
The total supply of Royal Capital 369 (RC369) is fixed to ensure transparency and long-term sustainability.

- Total Supply: **21,000,000 RC369**
- Decimals: 18
- Blockchain: BEP-20 (**Binance Smart Chain**)

No inflation mechanism exists beyond the predetermined total supply.

10.2 Token Allocation and Distribution

Token distribution is structured to balance early funding needs, liquidity, community growth, and long-term ecosystem sustainability.
